The following provisionally Selected candidates having Domicile of Khyber Pakhtunkhwa are advised to download and submit original Bank Deposit Slip (Can be deposited in any HBL Branch) along with Undertaking/Deeds of Agreement duly attested by Oath Commissioner/Notary Public on judicial stamp paper (Undertaking specimen is attached) along with **three copies of HSSC (2nd year) DMCs** and any other deficient documents (if any) in the Directorate of Teaching, The University of Agriculture, Peshawar, from **19/09/2025 to 22/09/2025 (till 03:00 pm)**.

2. The name of the following candidates are provisionally reflected in the merit list subject to provision of clear HSSC Part-II (2nd Year) DMC. The provisional admission of those candidates who fail to meet the minimum eligibility criteria in HSSC Part-II (2nd Year) result will be cancelled as per university rules and fees will be refunded.

3. The Candidate(s) who failed to submit Bank Slip and Undertaking on or before the aforementioned last date & Time, their seats will be allotted to next deserving candidate(s) from the waiting list and he/she will lose the right of admission.

4. Provisional admission will be granted to students on the basis of merit, subject to the verification of documents of all the admitted students from the concerned Board and found eligible. Incorrect information, conceal of fact or submission of fake document(s) by the applicant, his/her right of admission will be forfeited at any stage, for being guilty of gross misconduct & a criminal act on the part of concerned candidate.

5. Candidates who have any observations regarding adjustment of marks etc may contact the Directorate Of Teaching immediately.

6. Errors and omission if any, will be accepted.

Note:

The candidate(s) shall not deposit admission fee who have:

i. Not completed HSSC degree requirements (failed any subject of HSSC)

ii. 3rd division in SSC/HSSC examinations

iii. Attained or shall attain age of 25 years on the last date of the submission of application forms
