 - i. SSC DMC
 - ii. HSSC 1st year DMC
 - iii. HSSC 2nd year DMC
 - iv. SSC Certificate
 - v. Domicile Certificate
 - vi. Three duly attested passport sized photographs
2. The name of the following candidates are provisionally reflected in the merit list subject to provision of clear HSSC Part-II (2nd Year) DMC. The provisional admission of those candidates who fail to meet the minimum eligibility criteria in HSSC Part-II (2nd Year) result will be cancelled as per university rules and fees will be refunded. Candidates are directed to check their eligibility for the concerned degree program, before depositing the dues.
3. The Candidate(s) who failed to deposit online fee and submission of admission forms along with required documents / Undertaking in Directorate of Teaching, the University of Agriculture, Peshawar on or before the aforementioned last date & time, their seats will be allotted to next deserving candidate(s) from the waiting list and he/she will lose the right of admission.
4. Provisional admission will be granted to students on the basis of merit, subject to the verification of documents of all the admitted students from the concerned Board and found eligible. Incorrect information, conceal of fact or submission of fake document(s) by the applicant, his/her right of admission will be forfeited at any stage, for being guilty of gross misconduct & a criminal act on the part of concerned candidate.
5. Candidates who have any observations regarding adjustment of marks etc may contact the Directorate Of Teaching immediately.
6. Errors and omission if any, will be accepted.

NOTE:

The candidate(s) shall not deposit admission fee who have:

- i. Failed any subject of HSSC
- ii. Not completed HSSC degree requirements with atleast 45% marks
- iii. 3rd division in SSC/HSSC examinations
- iv. Attained or shall attain age of 30 years on the last date of the submission of application forms.
